2. Bank account details (account number, account holder name, bank name, IFSC code) in which the amounts collected as application fee or as additional fee under RTI act are deposited by your office.
3. Certified details of the SPIOs/AAs appointed under RTI act to deal with the applications received in your office.
4. Please supply the certified copy of the documents showing procedure followed (proposals, file noting, advertisements, tenders, quotations, proceedings, minutes, correspondence, orders, allotment letters etc) for allotment of parking space of Red Cross Bhawan, Hisar. The information may be supplied for the period since 01.04.2019.
5. Please supply the certified copy of the terms and conditions of the allotment of the parking space as mentioned in the Para I above.

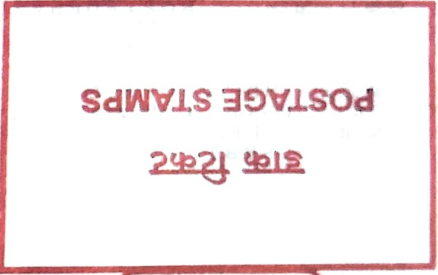

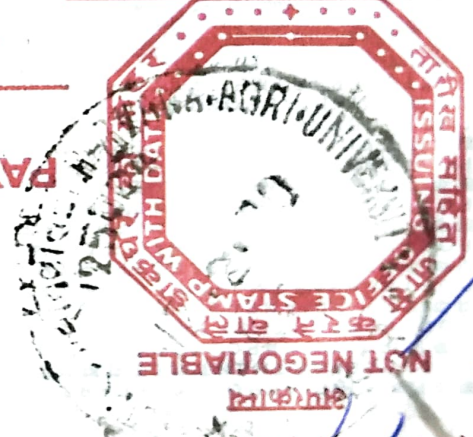
